**Registration Information**

Thank you for your interest in the 2017 San Diego Defense Lawyers Mock Trial Competition. In recent years, the number of law schools wishing to enter teams in the SDDL Mock Trial Competition has increased greatly. In order to maintain the quality of the competition, and to insure that teams from the greatest number of law schools are able to participate, we have changed some of our policies and procedures. **Please read the following Registration Information carefully as it may differ from the past years:**

**REGISTRATION OPENS** ..... **May 5, 2017**  
*(Registration Applications received earlier than this date will not be given priority.)*

**REGISTRATION FEE (Non-Refundable after August 4, 2017)** ..... **\$425.00 per Team**  
*(Mail Application and Fee to SDDL Mock Trial Competition, ATTN: Gabriel Benrubi, 591 Camino de la Reina, Suite 640, San Diego, CA 92108.)*

**REGISTRATION CUT-OFF** ..... **August 25, 2017**

**MULTIPLE TEAMS:** If your school wishes to field a second team, you must be sure to indicate this on your Registration Application. PLEASE NOTE that only one (1) team will be confirmed as registered prior to the Registration Cut-Off Date. The registration of your “Team 2” will be held in abeyance until after the Registration Cut-Off Date. Assignment of second teams will be determined on a first come-first served basis, depending upon the number of open positions after the Registration Cut-Off date. A school will not have been considered to register a “second team” unless it does so on or after the registration opening date of May 5, 2017. Confirmation of Registration of your “Team 2” will be sent within ten (10) days after the Registration Cut-Off Date. Applications for more than two (2) teams per school will not be accepted. If, after the Registration Cut-Off Date a school withdraws one of its two teams from the Competition, the other team from that school, in the discretion of SDDL, may also be required to withdraw to maintain a proper number of teams overall.

**LATE REGISTRATION:** Registration Applications and/or Registration Fee checks received after the Registration Cut-Off Date will be accepted only to the extent that positions are available after the allocation of positions to previously received “Team 2” applications has been completed. *(See “MULTIPLE TEAMS,” above.)*

**MAILING of TRIAL MATERIALS** ..... **September 8, 2017**  
*(Trial Materials will be mailed USPS Priority Mail to the address indicated on your Registration Application.)*

**IDENTIFICATION of COMPETITORS and OTHER PARTICIPANTS** ..... **October 6, 2017**  
*(Each team must consist of four (4) competitors. The names of student competitors, coaches, advisers and guests must be provided to SDDL.)*

**SDDL MOCK TRIAL COMPETITION** ..... **October 19, 20 and 21, 2017**
